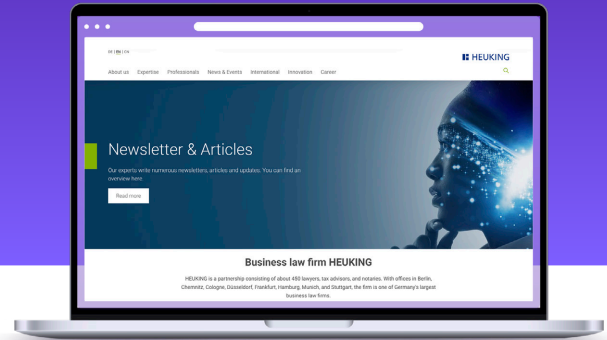

## Challenge
