THE SHARED RESPONSIBILITY MODEL

Atlassian protects the platform. You protect the data.

Atlassian's RDS snapshots exist for platform-level disaster recovery. They will not roll back customer-initiated destructive changes like deleted projects, overwritten fields, bad scripts, rogue admins, or ransomware. Backing up your own data is your responsibility.

NATIVE TOOLING IS GAPPED

Atlassian's native Backup and Restore went GA in 2026 as a paid add-on for Premium and Enterprise. It covers the basics, enterprises hit its ceiling fast.

What atlassian native backup does	Structural gaps HYCU closes
Apps in scope Jira, JSM, JPD, and Confluence only	→ Hard size caps. 300 GB Jira / 32 GB Confluence / 7M attachments; you cannot purchase above these limits.
Schedule and storage Daily or weekly; Atlassian-owned storage only	→ No Bitbucket, no Trello. Git repos, Trello, Rovo, and Marketplace app data are outside scope entirely.
Retention 30 days maximum in Atlassian storage	→ No granular restore. Cannot restore a single project, space, issue, or page. All or nothing.
Encryption Atlassian-managed keys or BYOK via AWS KMS	→ No automation coverage. Jira and Confluence automations are not backed up or restored.
Sandboxes Restore into empty sandbox; sandbox backups supported	→ No BYOC going forward. AWS S3 BYOC closed to new customers. No Azure, GCP, Dell, Wasabi, or on-prem.
Automated restore Weekly restore drill (health check)	→ No unified view. Per-app and per-site. No cross-org or cross-workload visibility.

A THIRD-PARTY PLATFORM IS CRITICAL

Every enterprise faces these five vectors, and none are covered by single-app native tools.



Accidental deletion
Human error deletes the wrong project, epic, or page.



Malicious insider
Rogue admins or compromised accounts corrupt data at scale.



Supply-chain attack
Compromised Marketplace apps inject bad data or delete records.



Configuration drift
Bad automations or bulk edits corrupt production; no rollback



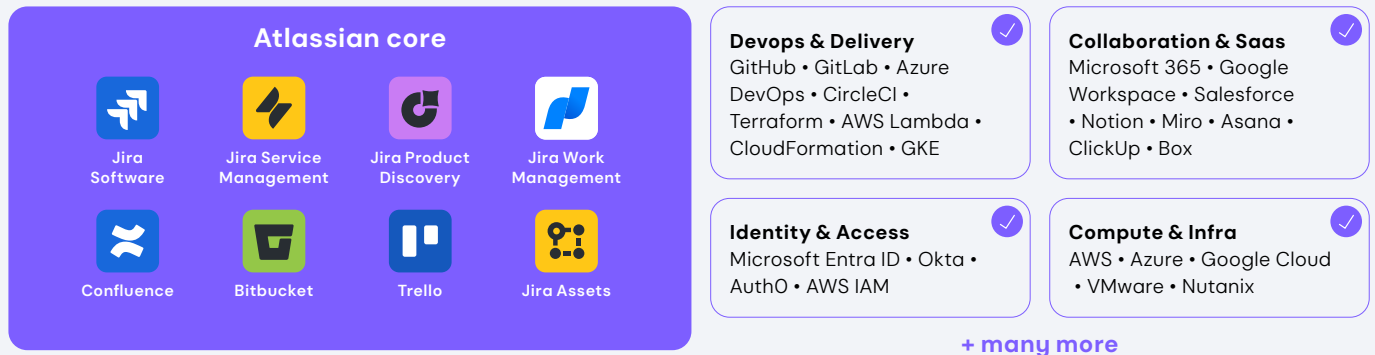
Compliance and audit

Platform-Level Coverage	Jira, JSM, JPD, JWM, Confluence, Bitbucket, Trello, and Assets, protected as one system.
